Re: LHSIA s. 20 Notice and Extension of Service Accountability Agreement(s) ("Extending Letter")

The Local Health System Integration Act, 2006 requires the Central East Local Health Integration Network (the "Central East LHIN") to notify a health service provider when the Central East LHIN proposes to enter into, or amend, a service accountability agreement with that health service provider.

In this COVID-19 outbreak, the Central East LHIN hereby gives notice and advises CVH (No 6) - Port Perry Place (the "HSP") of the Central East LHIN's proposal to amend each and every service accountability agreement (as described in the *Local Health System Integration Act, 2006*) currently in effect between the Central East LHIN and your organization (each a "SAA").

- 2) Schedules The Schedules in effect on June 29, 2020 shall remain in effect until March 31, 2021, or until such other time as may be agreed to by Parties.
